**Important Information :-**

To avoid disappointment, please read the conditions of entry attached, before submitting your Entry Form. Please submit entries ASAP in time to receive your entry tickets by post, and provide an SAE. Exhibitors, their partners and children, (immediate family only) all carried in the same vehicle with a valid Exhibitors Pass, will receive **FREE** entry to the show, Exhibitors only will receive **FREE** Complimentary drink refreshments, **FREE** Camping. Steam Exhibitors in addition will receive **FREE** Steam Coal & Water Supply.

- 4) Stationary Working Engines **Closed - This class full**

- 6) Classic & Vintage Cars **Closed- This class full.**
- 7) Classic / Vintage Motorcycles **Still open** -
- 8) Tractors & Farm machinery **Closed - This class full**
- 9) Surface Warship Association **(Members Only)**

**Conditions of Entry:-**

- 1) Drivers of any vehicle on the Show Ground must have a **valid drivers licence**, and **Insurance** for that vehicle as required by the Road Traffic Act.
- 2) All Steam working exhibits must be **Insured for Public Liability** for a least £2,Million pounds, and have a **valid Boiler Certificate**.
- 3) Exhibits must always be in a **safe condition** whether working or not.
- 4) **Hot or Working** stationary engines of any type, must have someone in attendance at all times of operation, and will be roped off. (Road pins and ropes will be supplied by Bicton Gardens).
- 5) A speed Limit of 5 Mph will apply to all places on the Show Ground.
- 6) All exhibits fitted with, or attached to, mains electrical supply, internal or external, will have been fitted with fuses according to current electrical regulations, and have been tested to Health & Safety Standards. Portable Generators will have residual current breakers fitted.
- 7) Please display your Exhibit Tickets on the front of all vehicles entering the site, which helps staff direct you to your pitch. Only vehicles carrying, or towing exhibits will be permitted entry, and those of course which are exhibits in their own right, such as Classic Cars, Military vehicles etc.
- 8) Exhibits & Exhibit Transport parking places at the show ground will be allocated or your arrival by the Event Staff.
- 9) For Public Safety, movement of any Exhibits around the grounds during opening times, will only be by the strict permission of the Management or Event Manager.
- 10) Mobile or Stationary Hot Operating Steam Engines of any sort, must have someone in attendance at all times, and the operators must be responsible for their safe operation, and risk assessment during operation on site.
- 11) Management reserve the right to refuse entry / admission to any exhibitor, or accompanying personnel, or to require them to vacate the ground should they Breach any of these terms, or become a danger to any members of the Public, or behave in an unacceptable manner.
- 12) The loading and unloading operation of exhibits off any vehicle or trailer, must be risk assessed by their owners / exhibitors, and handled in a safe manner for all persons present.
